# **Terms and Conditions**

## Changing your mind

If you change your mind, you have the right to cancel and withdraw your application during a 14-day period from the date you accepted our offer.

If you submitted your application through UCAS, you are able to cancel your entire UCAS application and receive a refund by contacting UCAS within 14 days of the date on your UCAS welcome email. However, if you withdraw your application after 14 days you will not be eligible for a refund.

You are able to change your Firm and Insurance choice replies once within 14 days of accepting the offer. However, if you wish to change your replies more than once or more than 14 days after replying, UCAS will require permission from all the providers affected before any change occurs.

#### Subject to validation

If a course is being introduced for the first time you will have received a message to say your course is 'Subject to Validation' in your offer letter. Validation is the process we use to ensure any new course provides a distinct, high quality academic experience for our students that enables you to acquire the necessary academic knowledge, understanding, general and subject-specific skills required to pursue a graduate level career. In the unlikely event that a programme is not validated then we will do everything we can to find you an alternative course at the University.

#### Subject to re-validation

Re-validation is the process we go through to review, refresh and update courses. This process ensures our courses maintain high standards and provide a distinct, high quality academic experience for our students, enabling you to acquire the necessary academic knowledge, understanding, general and subject-specific skills required to pursue a graduate level career.

## **Professional accreditation**

Some of our courses are accredited by a professional body and where applicable this is shown on your offer letter. Accredited courses count towards professional qualifications or registration with a professional body – which can benefit you in your career and, in some cases, be a legal requirement of the profession. Not all courses require professional body accreditation and some subject areas do not have a recognised professional body. Accredited courses are only really necessary if there is a professional qualification in the industry you plan to work in. Whether your course is accredited or not, we offer a learning environment where you will be supported and challenged to reach your full potential for a successful and fulfilling life.

#### Fees and financial support

If finance is a worry for you, we are here to help. #### Deposits

Students from outside the UK are required to pay a deposit once accepting the offer of a place. If you are a student from a country listed by the UKVI as exempt from providing evidence that you meet the financial requirements for your visa, you will be required to submit a Tuition Fee Deposit of GBP 2000.

If you are a student from a country not listed by the UKVI as exempt from providing evidence that you meet the financial requirements for your visa, you will be required to submit a Tuition Fee Deposit of GBP 5000.
